Human Rights and Democracy Media Center "SHAMS"

Condemns a death sentence issued by the Permanent Military Court in Gaza Strip against a citizen from Almaghazy

"SHAMS" center condemns issuing a death sentence against a citizen from Gaza Strip by the Permanent Military Court on Thursday 20/6/2013. "SHAMS" center also reminds that the reference of the High Military Court rules are the texts of penal revolutionary law issued by the Palestinian Liberation Organization (PLO) in 1979 which is an unconstitutional law since it hasn't been yet declared by the Legislative Council either in legislation or declaration, as well many articles of the mentioned law contradicts the International Bill of Human Rights and related international Charters.

"SHAMS" center **emphasizes** the illegality of judging civilians within military courts in contradiction of just trial instead of the judge, while death penalty doesn't represent a restrain against crimes according to the experiences of different countries which apply this penalty.

"SHAMS" center stresses the right of the accused people to have legal guarantees and to secure applying the most accurate and certain legal procedures concerning individuals who are accused to crimes with death as its penalty, taking into consideration that accused individuals' use their right to appeal legally or ask a pardon or commutation.

"SHAMS" center claims the importance to cancel death penalty from Palestinian legislations and replace it with another penalty like several Arabic or foreign countries since death is considered as one of the most heinous penalties and a form of murder. Death is also a cruel and harsh penalty besides, it doesn't achieve objectives that the country quests and it is impossible to repeal it if the penalty is executed or if the accused individual was innocent.
