## Human Rights and Democracy Media Center- SHAMS

May 2023



The report is within the process of documenting the Israeli occupation authorities' violations against the Palestinian houses and establishments including demolition, notifying of demolition, and eviction. The report is based on the data collected from the field through the field and researching team of Human Rights and Democracy Media Center- SHAMS. The report covers the period 1- 31/ 5/2023 in the West Bank, including Jerusalem and reflects the accumulated efforts of the organization's documentation and fieldwork teams.



**Overall Statistics:**

During May 2023, Human Rights and Democracy Media Center- SHAMS documented targeting 164 Palestinian establishments, by the Israeli authorities. Targeting the establishments was through demolishing of notification with demolishing orders or stop construction or eviction, where the notified establishments will be targeted in the near future.

The major form of violations was demolishing where 89 establishments were targeted including 6 establishments where the owners were forced to demolish them on their own to avoid paying high financial fines or being arrested.

Concerning the notifications, the Israeli authorities notified the owners of 75 establishments with military orders of demolishing, stopping construction, or evicting. The notified establishments included houses, residential rooms, residential barracks, agricultural establishments, commercial establishments, livestock barracks/ sheds, water wells, and stones quarry. In Um Al- Jimal area- Northern Jordan Valley, the Israeli authorities notified the owners of 7 residential barracks with demolishing orders under the claim of being built in a military closed areas. Two of the given barracks are owned by women: Fatima Nassar Caabna and Abeer Awad Caabna.

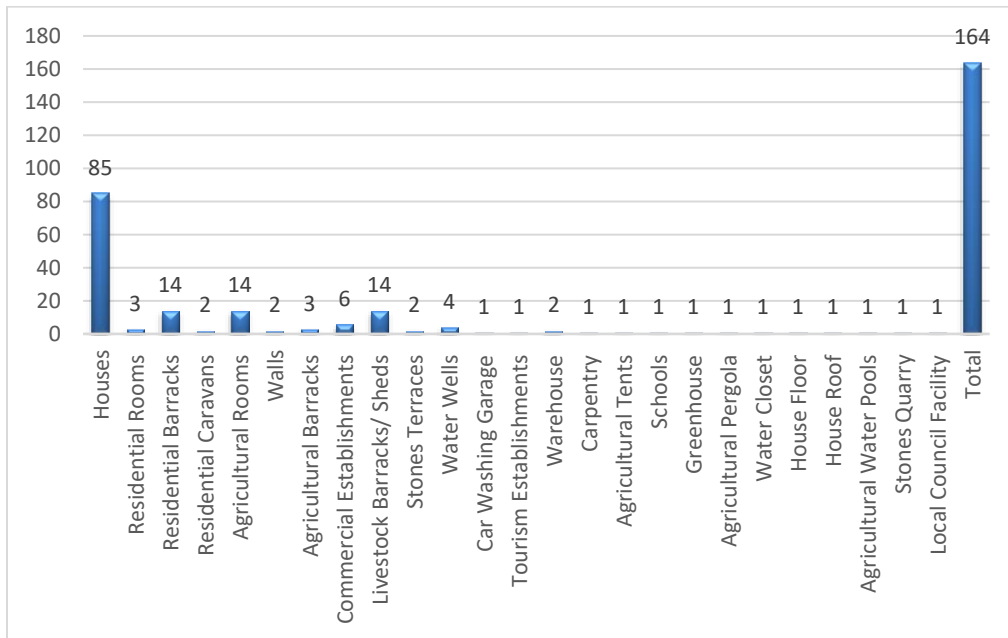

**Types of targeted establishments (Demolished/ Notified)**



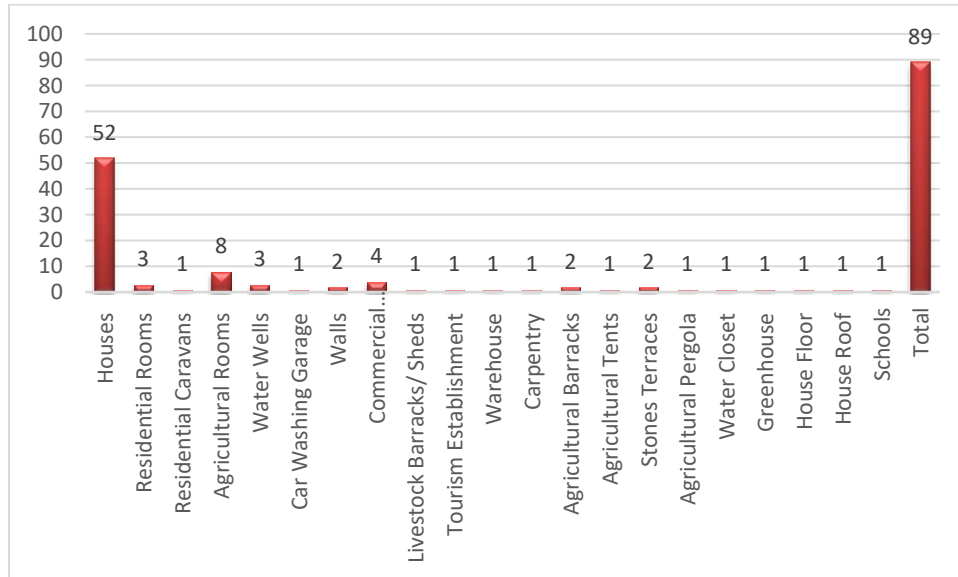

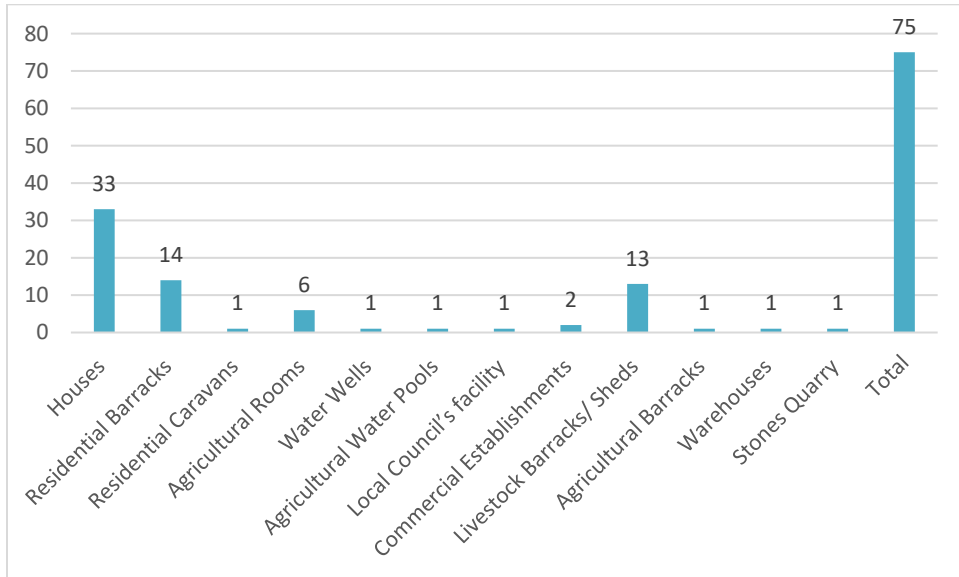

**Geographical Distribution of the Targeted Establishments:**

- **Geographical Distribution of the Demolished Establishments:**

According to the indicator of the geographical distribution of the demolished establishments, the majority was in Jerusalem (40 establishments). There were (16) establishments demolished in Hebron Governorate. The term establishment in this sense refers to any type of establishments detailed in table # 4 above. SHAMS Center documents the demolished establishments distribution among the various governorates of the West Bank where during May, the demolished establishments were as follows:

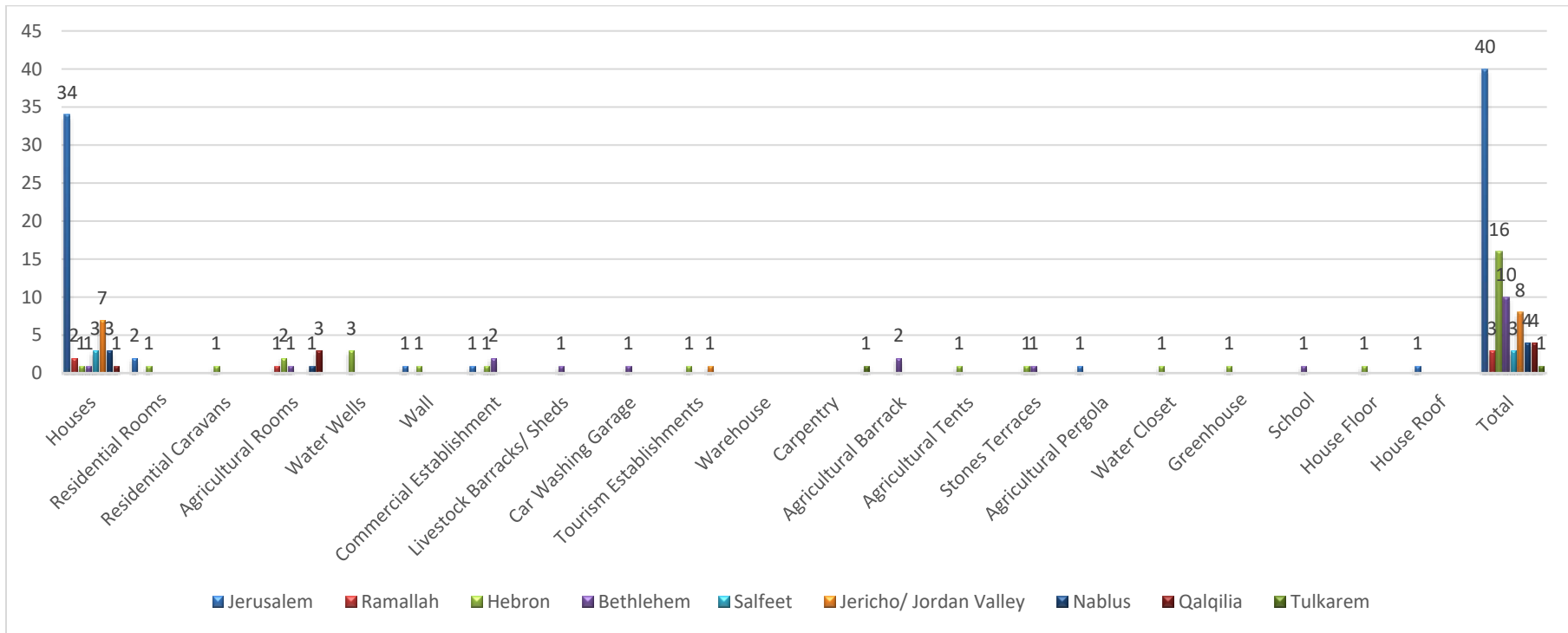

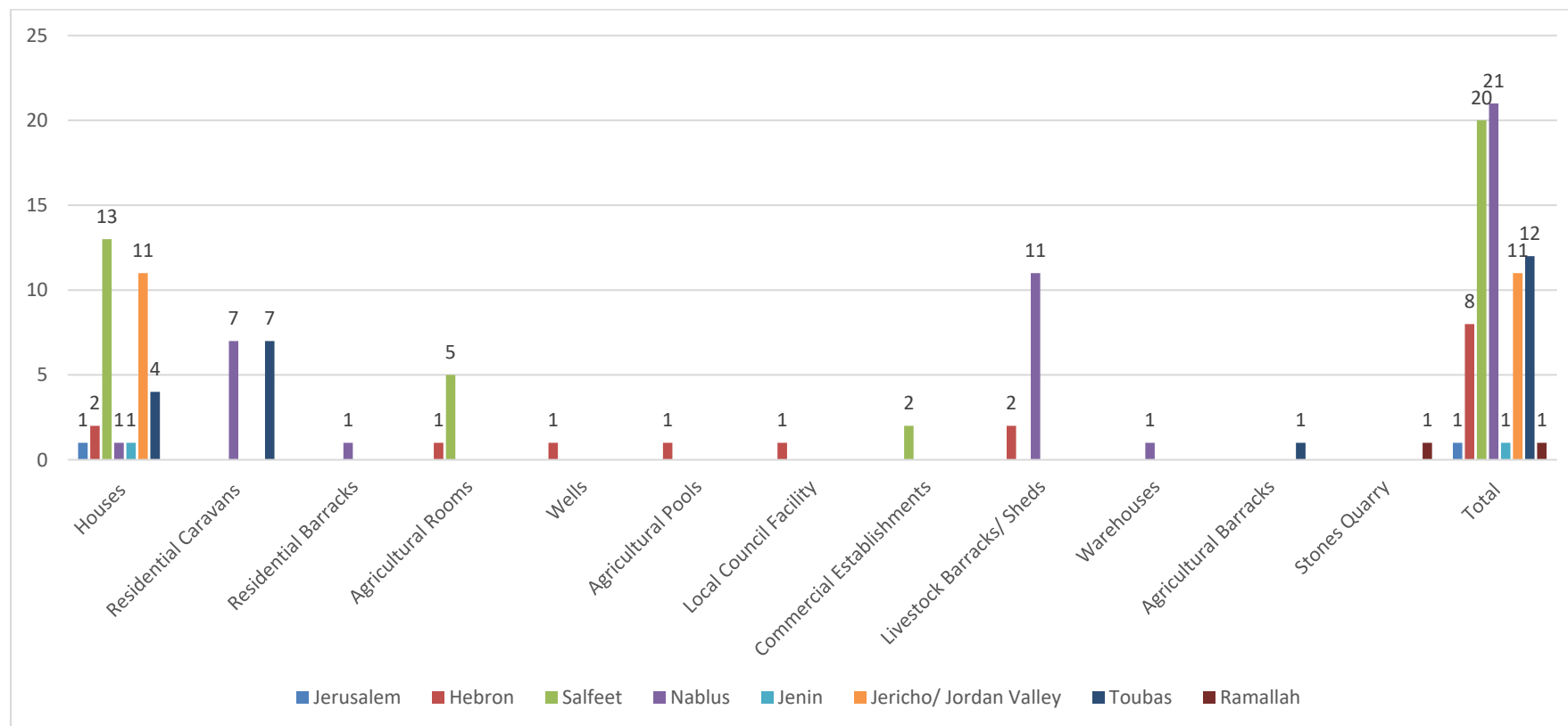

### Geographical Distribution of the Notified Establishments



- **Demolishing/ Notifications for Security Reasons:**

The Israeli authorities utilize home- demolition as collective punishment against Palestinians involved in resisting the occupation in order to deter others from involving in the resistance. During May, the Israeli authorities demolished 5 houses in Qalqilia, Salfeet, and Ramallah Governorates (as detailed in the following table) within the policy of collective punishment:

- **Self- Demolishing:**

Self- demolishing is structured oppression practiced against Palestinians where Palestinians (mainly Jerusalemites) are obligated to demolish their establishments on their own to avoid paying high financial fines or even being arrested in case they do not do. In case the Israeli machines demolish the targeted establishment, then the owner should pay the cost of the demolishing process as estimated by the Israeli authorities themselves. Self- demolishing is a clear manifestation of the apartheid racist policy applied against Palestinians and stands as crime where the victims are obligated to participate in the crime committed against themselves.

During May, the Israeli authorities obligated 6 Palestinians to demolish their establishments on their own, under the claim of unlicensed building

- **Targeted Population:**

71 Palestinians were affected by the violations of the Israeli authorities against Palestinians establishments during May.

- **Claims of Violations:**

As for the claims presented by the Israeli authorities to legalize the crimes against Palestinian establishments, 80 establishments were demolished during May under the claim of unlicensed building in areas classified as (c). 5 houses were demolished within the policy of collective punishment against Palestinians involved in the national resistance. 3 houses were demolished during Israeli invasions of Palestinian localities and persuading Palestinian youth who are wanted by the Israelis. An establishment (carpentry) was demolished under the claim that it contains iron lathe used to manufacture weapons.

Concerning the notifications, the Israeli authorities notified the owners of 65 establishments under the claim of unlicensed building in areas classified as (C). The owners of one house were notified within the policy of collective punishment applied against Palestinians involved in resisting the occupation. The owners of two establishments were notified to evict their establishment under the claim that they are owned by Jews. The owners of 7 establishments were notified with demolishing orders of their residential barracks under the claim that they are built in a closed military zone.
